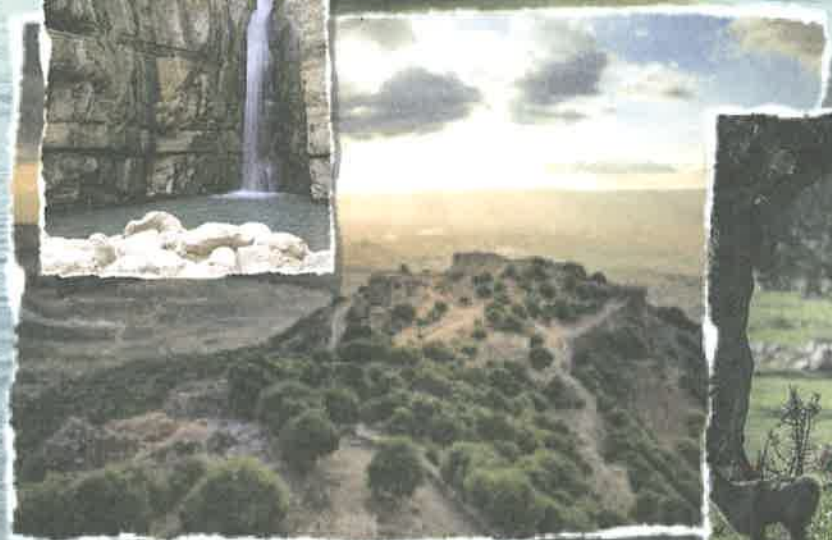
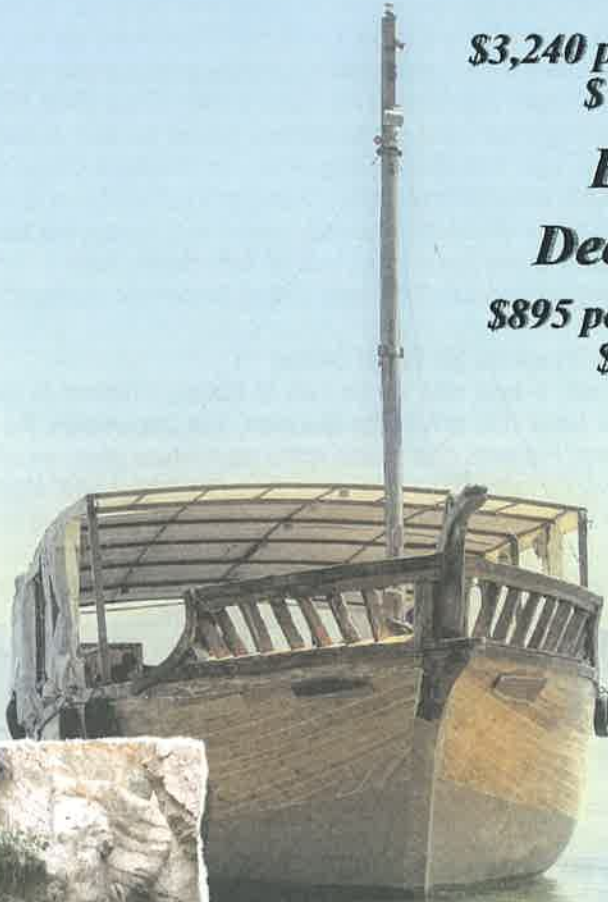

Day 1 – Monday – November 27: USA – Israel

Depart on an overnight flight to Tel Aviv.

Day 2 – Tuesday – November 28: Arrival – Jaffa - Tel Aviv

Upon arrival at Ben Gurion airport you will be met and assisted by a Coral Travel & Tours representative at the airport. Meet your guide and drive to **Jaffa**. Jaffa has been known in the bible as Joppa and is considered the world's oldest port and the place where the prophet Jonah set sail for Tarshish. Jaffa is associated with the deeds of Peter. Tabitha was resurrected by St Peter (Acts 9: 35-43) in Jaffa and Peter went to Caesarea to convert Cornelius after the vision at the house of Simon the Tanner (Acts 10: 1-23). After a short drive through Tel Aviv, check into your hotel. Dinner and overnight: Hotel in Tel-Aviv.

Day 3 – Wednesday – November 29: Caesarea - Mt. Carmel – Megiddo – Sea of Galilee

After our Israeli breakfast travel via the Sharon plain to **Caesarea**. Caesarea was the seat of the Roman Procurator of the Judea in the time of Christ and the place St. Peter converted the Centurion Cornelius. (Acts 10:24). Explore the Roman Theater and the aqueduct and view the ruins of Roman, Byzantine and Crusader times. Continue to **Mt. Carmel**, to the "**Mukhraka**" the site where Elijah challenged and defeated the 450 prophets of Baal. (King 18:20). Visit the IPHC Ministry in Haifa, **Living Israel**. Drive via the ancient "Way of the Sea" to **Megiddo**, the fortress city of King Solomon, later built upon by King Ahab. The books of Daniel and Revelation will come alive as we study about the final Battle of Armageddon (Revelation 16: 14-19). Viewing the Plains of Jezreel. Continue on through **Nazareth**, the home of Joseph and Mary and through the city of Cana of Galilee where Jesus performed his first miracle (John 2: 1-11): turning jars of water into wine. Drive to Tiberias on the Sea of Galilee. Dinner and overnight: Hotel in Tiberias.

Day 4 – Thursday – November 30: Sea of Galilee

The day will start with a **boat ride** on the Sea of Galilee. Continue to the "**ancient boat**" believed to be from Jesus' time at **Kibbutz Ginossar**. Visit **Capernaum**, the town Jesus made his home after leaving Nazareth. Capernaum is the place where Jesus recruited the first of His disciples (Matthew 4:13, Luke 4:31-37, Matthew 8:14-17, Mark 2:1-12, Matthew 8:5-13, Mark 5:21-43, Matthew 11:23-24). Visit the excavation of the ancient synagogue and the house of St. Peter. Then, visit the **Mount of Beatitudes**, where Jesus delivered the Sermon on the Mount (Matthew 5:1-12). Drive to **Tel Dan**, an important biblical city and a breathtaking nature reserve. The bible mentions the city few times: "From Dan to Beer Sheba". Continue to the **Banias**, site of the ancient **Caesarea Philippe**. It is here that Peter made his confession of faith in Jesus (Matthew 16:13). Enjoy a panoramic view of the Golan Heights from **Mt. Bental**. Return to Tiberias. Dinner and overnight: Hotel in Tiberias.

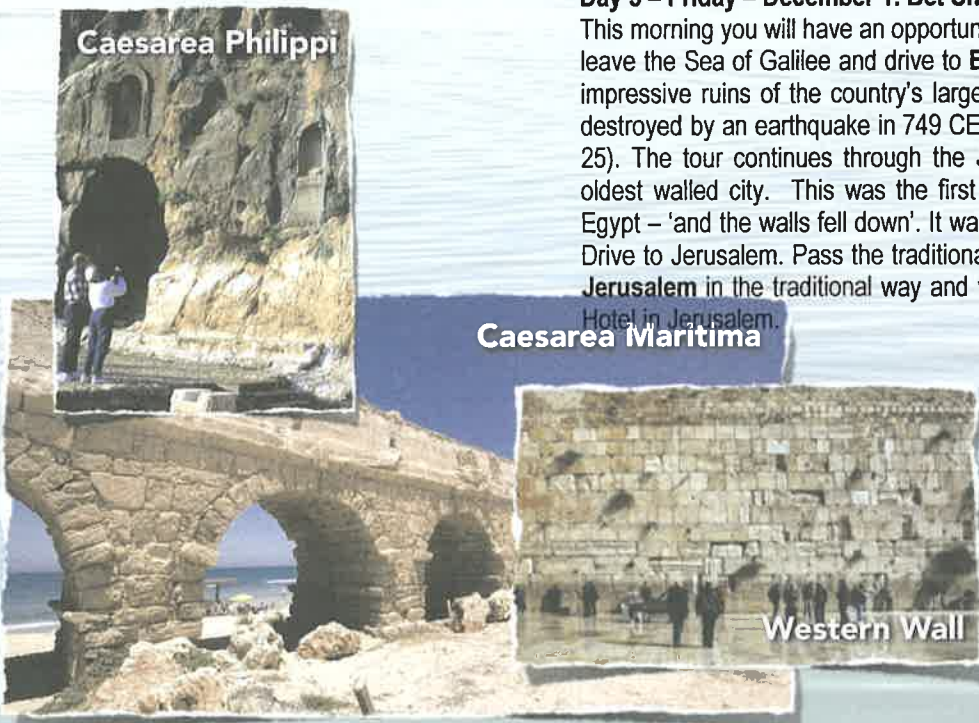
Day 5 – Friday – December 1: Bet She'an – Bet Alfa - Jerusalem

This morning you will have an opportunity to be **baptized (optional)** at the **Jordan River**. Then, leave the Sea of Galilee and drive to **Bet She'an**. Recent excavations there have disclosed the impressive ruins of the country's largest city in the Roman and Byzantine periods, which was destroyed by an earthquake in 749 CE. Visit **Ein Harod**, the site of Judge Gideon (Judges 7: 1-25). The tour continues through the **Jordan Valley** past Jericho, believed to be the world's oldest walled city. This was the first city taken by Joshua when the Hebrews returned from Egypt – 'and the walls fell down'. It was also the site of the **Mount of Temptation**. (Mark 1:13). Drive to Jerusalem. Pass the traditional site of the Inn of the Good Samaritan. Enter the city of **Jerusalem** in the traditional way and view the city from **Mt. of Scopus**. Dinner and overnight:

Hotel in Jerusalem.

Day 6 – Saturday – December 2: Jerusalem - Bethlehem

After breakfast ascend the **Mount of Olives** (Matthew 24:3, Luke 21:37) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the **Palm Sunday Way** to the **Garden of Gethsemane** (Matthew 26:36-46, Luke 22:39-45, Mark 14:32-42) where Jesus spent the last night before he was arrested. Walk along the “**Last Way**” to **Mt. Zion**. Cross the **Kidron Valley** and see the Tombs of Absalom, Zachary and James. Drive to **Mt. Zion** and visit the **house of the high priest Caiphas**. Visit the **Church of St. Peter in Gallicantu**. This is the Place where St. Peter denied his Lord 3 times. You’ll also visit the **Church of St. Anne** and see the **Pools of Bethesda**, the **Last Supper Room** and **King David’s Tomb**. In the afternoon visit **Bethlehem**, **Shepherds’ Fields** and the **Church of Nativity**. Evening Service with IPHC Congregation in Bethlehem. Return to Jerusalem. Dinner and overnight: Hotel in Jerusalem.

Day 7 – Sunday – December 3: Massada – Ein Gedi - Qumran – Dead Sea

After an early breakfast depart and travel along the shore of the **Dead Sea**, the lowest place on earth to **Massada**. Ascend Massada by cable car. Massada is the site of the most dramatic act in Jewish history. Explore the ancient excavation of Herod’s Palaces, the bathhouse, the storerooms, the ramp and the oldest synagogue in the world. Continue to **Ein Gedi**, the desert oasis where David hid from Saul, visit the oasis and hike to the waterfall. Drive to **Qumran**, where the Dead Sea Scrolls were found. Enjoy an afternoon “**float**” on the **Dead Sea**. Return to Jerusalem. Dinner and overnight: Hotel in Jerusalem.

Day 8 – Monday – December 4: Jerusalem

The day starts with a drive to the western side of the city to visit to **Yad Vashem**, the Holocaust Museum. Continue to the **Israel Museum** where the Dead Sea Scrolls are kept in the **Shrine of the Book** and the **Holy Land model** of Jerusalem as it was in the Second Temple period (the time of Jesus). In the afternoon visit the **City of David** and **Warren’s Shaft**. End the day with a visit to the **Friends of Zion Museum**. Dinner and overnight: Hotel in Jerusalem.

Day 9 – Tuesday – December 5 Jerusalem – Tel Aviv - Departure

The day starts with a visit to **Mt. Moriah**. Walk through the Jewish Quarter to the **Western Wall**. Visit the **Southern Wall excavation** (Davidson Center) and the **Rabbinical Tunnel**. Continue to **St. Anne’s Church**, which is a fine example of Crusader architecture, and the **Pools of Bethesda**. Walk through the **Christian Quarter**. **Farewell dinner**. Overnight: Hotel in Jerusalem.

Day 10 – Wednesday – December 6: Tel Aviv - USA

Transfer to the airport for your flight back home. Arrive USA the same day.

EGYPT EXTENSION

Day 10 – Wednesday – December 6: Tel Aviv - USA

Arrival Cairo international airport. You will be met and assisted at the airport by a Coral Travel representative. Visit to the area of **Old Cairo** and the **Hanging Church**. Transfer to our hotel. Dinner and overnight at Hotel in Cairo.

Day 11 – Thursday – December 7: Tel Aviv - USA

After breakfast travel to ancient Egypt with a full day of touring the wonders of the ancient world, some of which date back to 1000+ years prior to Abraham. We spend time at one of the seven wonders of the world- the **Pyramids, Cheops**, with an original height of 496 feet, is the most colossal pyramid ever built. Stop by a papyrus factory before we do a panoramic view of Cairo including the **Egyptian Museum**. Dinner and overnight at hotel at Hotel in Cairo.

GENERAL EXCLUSIONS

Insurance benefits are not payable for any loss due to, arising or resulting from:

1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked to travel with You, while sane or insane;
2. an act of declared or undeclared war;
3. participating in maneuvers or training exercises of an armed service, except while participating in weekend or summer training for the reserve forces of the United States, including the National Guard;
4. riding or driving in races, or speed or endurance competitions or events;
5. mountaineering (engaging in the sport of scaling mountains generally requiring the use of picks, ropes, or other special equipment);
6. participating as a professional in a stunt, athletic or sporting event or competition;
