Day 1 – February 26 - Monday: USA – Tel Aviv

Flight to Tel Aviv.

Day 2 – February 27 - Tuesday: Arrival – Jaffa - Herzeliya

Upon arrival at Ben Gurion airport, you will be assisted with customs & immigration along with the transfer of luggage before boarding your bus and drive to **Jaffa**, one of the oldest cities in the world. Visit the House of Simon the Tanner, & walk through Jaffa's reconstructed Old Quarter. Drive to Herzeliya. Dinner & Overnight: Hotel in Herzeliya.

Day 3 – February 28 - Wednesday: Caesarea – Megiddo – Sea of Galilee

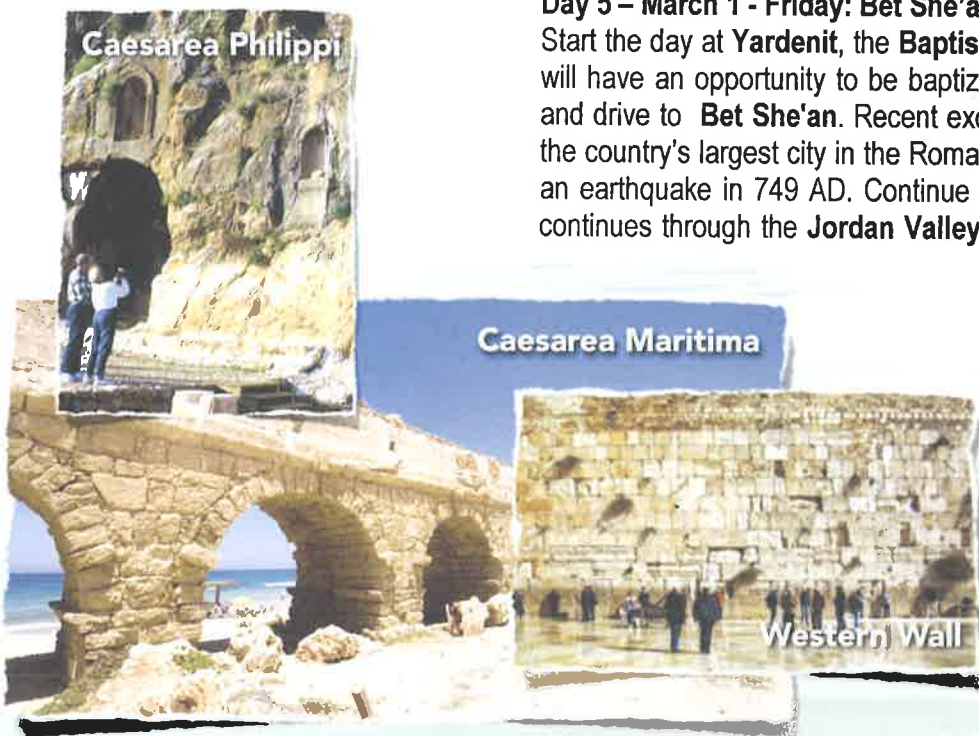
After breakfast drive the Sharon Plains to **Caesarea**, the seat of the Roman Procurator of Judea at the time of the Christ, & the site where Peter converted the Centurion Cornelius. This fortified harbor city was built 2000 years ago by King Herod the Great. View the ruins of Roman, Byzantine & Crusader times. Explore the Roman Theater & the Aqueducts. A drive-up **Mt. Carmel** will bring us to the site where Elijah challenged & defeated the 450 prophets of Baal. Continue to **Megiddo**, the Fortress City of King Solomon, later built again by King Ahab. The books of Daniel & Revelation will come alive as we study about the final Battle of Armageddon while viewing the Plains of Jezreel. Drive to Tiberias. Dinner & overnight: Hotel in Tiberias.

Day 4 – February 29 - Thursday: Caesarea Philippi - Sea of Galilee

The day starts with a drive to the **Mt. of Beatitudes**, site of the Sermon on the Mount. Drive along the **Hula Valley** to **Tel Dan** & visit the remains of the city. Continue on to **Caesarea Philippi**, where Peter made his confession of faith to Jesus. Via a ride through the Golan Heights we return to the northern shore of the Sea of Galilee, the area where Jesus spent his years of ministry. See the ruins of **Capernaum**, the town where Jesus made his home after leaving Nazareth. View the remains of the ancient synagogue, in which he may have preached, & the house of Peter. After a **boat ride on the Sea of Galilee** and a visit the "**Jesus Boat**" in Kibbutz Ginosar, visit **Tabgha** where the Miracle of the multiplication of the loaves & fishes took place. Drive to Tiberias. Dinner & overnight: Hotel in Tiberias.

Day 5 – March 1 - Friday: Bet She'an – Jericho - Jerusalem

Start the day at **Yardenit**, the **Baptismal Center** site on the Jordan River where you will have an opportunity to be baptized (optional). Then, depart the Sea of Galilee and drive to **Bet She'an**. Recent excavations have unveiled the impressive ruins of the country's largest city in the Roman & Byzantine periods, which was destroyed by an earthquake in 749 AD. Continue on to **Ein Harod – Gideon Springs**. The tour continues through the **Jordan Valley** past Jericho, believed to be the world's oldest



walled city. This was the first city taken by Joshua when the Hebrews returned from Egypt – 'and the walls fell down'. It was also the site of the **Mount of Temptation**. (Mark 1:13). Drive to Jerusalem. Pass the traditional site of the **Inn of the Good Samaritan**. Enter the city of **Jerusalem** in the traditional way & view the city from **Mt. Scopus**. Dinner & overnight: Hotel in Jerusalem.

Day 6 – March 2 - Saturday: Jerusalem

After breakfast we'll ascend the **Mount of Olives** (Matthew 24:3, Luke 21:37) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the **Palm Sunday Way** to the **Garden of Gethsemane** (Matthew 26:36-46, Luke 22:39-45, Mark 14:32- 42) where Jesus spent the last night before he was arrested. Visit the **Church of All the Nations**. Walk along the "last way" to Mt. Zion. Cross the **Kidron Valley** & see the **Tombs of Absalom, Zachary & James**. At Mt. Zion visit the **House of the High Priest Caiphas** and the **Church of Peter in Gallicantu** (Matthew 26:31-35). This is the place where Peter denied the Lord 3 times. Continue on to **The Last Supper Room** (Matthew 26: 17 25) & **King David's Tomb**. Today we will also visit the **Pools of Bethesda & St. Anne's Church**, which is a fine example of Crusader architecture. Dinner & overnight: Hotel in Jerusalem.

Day 7 – March 3 - Sunday: Massada – Ein Gedi – Qumran – Dead Sea

After breakfast depart from Jerusalem to the Dead Sea & visit **Massada**. Ascend Massada by cable car. Massada is the site of the most dramatic act in Jewish History. Explore the ancient excavation of Herod's Palaces, the bathhouse, the storerooms, the ramp, & the oldest synagogue in the world. Continue to **Ein Gedi**, an Oasis on the Dead Sea shore. Near the 200-meter-high waterfall is a cave where David had his famous meeting with King Saul (First Samuel 24: 1-23). A walk around the reservation confirms that Ein Gedi is one of the most beautiful reservations in the world. Visit **Qumran**, where the 2000-year-old Dead Sea Scrolls were found. Continue to the **Dead Sea** shore for an afternoon "float" on the sea. Return to Jerusalem. Dinner & overnight: Hotel in Jerusalem.

Day 8 – March 4 - Monday: Ella Valley – Bell Caves - Jerusalem

After breakfast drive to **Mt. Moriah**. Walk up to the Temple site & view the **Dome of the Rock & El Aqsa Mosque**. Visit the **Western Wall**, last remnant of the second Jewish Temple during the time of Jesus and the **Rabbinical Tunnel**. Walk through the colorful Bazaar to the Jaffa Gate and the **Davidson Center**. We will then leave Jerusalem and drive to **Bet Shemesh, Zorah** in the **Soreck Valley** and the **Ella Valley** where David fought Goliath. Return to Jerusalem. Dinner & overnight: Hotel in Jerusalem.

Day 9 – March 5 - Tuesday: Jerusalem

Begin your day with a visit to the **City of David** and **Warren Shaft**. Then, drive to the western side of the city & visit the famous **Menorah** (Israel symbol) near the Knesset (the Israeli Parliament). Continue to the **Shrine of the Book** & the **Holy Land walk-around model** of the city of Jerusalem as it was in the Second Temple period (the time of Jesus) at the **Israel Museum**. Continue to **Yad Vashem** the National Holocaust Museum. We'll end our visit in Jerusalem with a service at the **Garden Tomb**. **Farewell Dinner**. Overnight: Hotel in Jerusalem.

Day 10 – March 6 - Wednesday: Jerusalem – Tel Aviv – USA

Transfer to the airport for your flight home. Arrive the same day.
