Day 1 – February 26 - Monday: USA – Tel Aviv Flight to Tel Aviv.

Day 2 - February 27 - Tuesday: Arrival - Jaffa - Herzeliya

Upon arrival at Ben Gurion airport, you will be assisted with customs & immigration along with the transfer of luggage before boarding your bus and drive to **Jaffa**, one of the oldest cities in the world. Visit the House of Simon the Tanner, & walk through Jaffa's reconstructed Old Quarter. Drive to Herzeliya. Dinner & Overnight: Hotel in Herzeliya.

Day 3 - February 28 - Wednesday: Caesarea - Megiddo - Sea of Galilee


After breakfast drive the Sharon Plains to Caesarea, the seat of the Roman Procurator of Judea at the time of the Christ, & the site where Peter converted the Centurion Cornelius. This fortified harbor city was built 2000 years ago by King Herod the Great. View the ruins of Roman, Byzantine & Crusader times. Explore the Roman Theater & the Aqueducts. A drive-up Mt. Carmel will bring us to the site where Elijah challenged & defeated the 450 prophets of Baal. Continue to Megiddo, the Fortress City of King Solomon, later built again by King Ahab. The books of Daniel & Revelation will come alive as we study about the final Battle of Armageddon while viewing the Plains of Jezreel. Drive to Tiberias. Dinner & overnight: Hotel in Tiberias.

Day 4 - February 29 - Thursday: Caesarea Philippi - Sea of Galilee

The day starts with a drive to the **Mt.** of **Beatitudes**, site of the Sermon on the Mount. Drive along the **Hula Valley** to **Tel Dan** & visit the remains of the city. Continue on to **Caesarea Philippi**, where Peter made his confession of faith to Jesus. Via a ride through the Golan Heights we return to the northern shore of the Sea of Galilee, the area where Jesus spent his years of ministry. See the ruins of **Capernaum**, the town where Jesus made his home after leaving Nazareth. View the remains of the ancient synagogue, in which he may have preached, & the house of Peter. After a **boat ride on the Sea of Galilee** and a visit the "**Jesus Boat**" in Kibbutz Ginosar, visit **Tabgha** where the Miracle of the multiplication of the loaves & fishes took place. Drive to Tiberias. Dinner & overnight: Hotel in Tiberias.

Day 5 - March 1 - Friday: Bet She'an - Jericho - Jerusalem

Start the day at **Yardenit**, the **Baptismal Center** site on the Jordan River where you will have an opportunity to be baptized (optional). Then, depart the Sea of Galilee and drive to **Bet She'an**. Recent excavations have unveiled the impressive ruins of the country's largest city in the Roman & Byzantine periods, which was destroyed by an earthquake in 749 AD. Continue on to **Ein Harod – Gideon Springs**. The tour continues through the **Jordan Valley** past Jericho, believed to be the world's oldest



walled city. This was the first city taken by Joshua when the Hebrews returned from Egypt - 'and the walls fell down'. It was also the site of the Mount of Temptation. (Mark 1:13). Drive to Jerusalem. Pass the traditional site of the Inn of the Good Samaritan. Enter the city of Jerusalem in the traditional way & view the city from Mt. Scopus. Dinner & overnight: Hotel in Jerusalem.

Day 6 - March 2 - Saturday: Jerusalem

After breakfast we'll ascend the **Mount of Olives** (Matthew 24:3, Luke 21:37) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the Palm Sunday Way to the Garden of Gethsemane (Matthew 26:36-46, Luke 22:39-45, Mark 14:32-42) where Jesus spent the last night before he was arrested. Visit the Church of All the Nations. Walk along the "last way" to Mt. Zion. Cross the Kidron Valley & see the Tombs of Absalom, Zachary & James. At Mt. Zion visit the House of the High Priest Caiphas and the Church of Peter in Gallicantu (Matthew 26:31-35). This is the place where Peter denied the Lord 3 times. Continue on to The Last Supper Room (Matthew 26: 17 25) & King David's Tomb. Today we will also visit the Pools of Bethesda & St. Anne's Church, which is a fine example of Crusader architecture. Dinner & overnight: Hotel in Jerusalem.

Day 7 - March 3 - Sunday: Massada - Ein Gedi - Qumran - Dead Sea

After breakfast depart from Jerusalem to the Dead Sea & visit Massada. Ascend Massada by cable car. Massada is the site of the most dramatic act in Jewish History. Explore the ancient excavation of Herod's Palaces, the bathhouse, the storerooms. the ramp, & the oldest synagogue in the world. Continue to Ein Gedi, an Oasis on the Dead Sea shore. Near the 200-meterhigh waterfall is a cave where David had his famous meeting with King Saul (First Samuel 24: 1-23). A walk around the reservation confirms that Ein Gedi is one of the most beautiful reservations in the world. Visit Qumran, where the 2000-yearold Dead Sea Scrolls were found. Continue to the Dead Sea shore for an afternoon "float" on the sea. Return to Jerusalem. Dinner & overnight: Hotel in Jerusalem.

Day 8 - March 4 - Monday: Ella Valley - Bell Caves - Jerusalem

After breakfast drive to Mt. Moriah. Walk up to the Temple site & view the Dome of the Rock & El Aqsa Mosque. Visit the Western Wall, last remnant of the second Jewish Temple during the time of Jesus and the Rabbinical Tunnel. Walk through the colorful Bazaar to the Jaffa Gate and the Davidson Center. We will then leave Jerusalem and drive to Bet Shemesh, Zorah in the Soreck Valley and the Ella Valley where David fought Goliath. Return to Jerusalem. Dinner & overnight: Hotel in Jerusalem.

Day 9 - March 5 - Tuesday: Jerusalem

Begin your day with a visit to the City of David and Warren Shaft. Then, drive to the western side of the city & visit the famous Menorah (Israel symbol) near the Knesset (the Israeli Parliament). Continue to the Shrine of the Book & the Holy Land walk-around model of the city of Jerusalem as it was in the Second Temple period (the time of Jesus) at the Israel Museum. Continue to Yad Vashem the National Holocaust Museum. We'll end our visit in Jerusalem with a service at the Garden Tomb. Farewell Dinner. Overnight: Hotel in Jerusalem.

Day 10 - March 6 - Wednesday: Jerusalem - Tel Aviv - USA

Transfer to the airport for your flight home. Arrive the same day.
