**Day 1 – Saturday – February 5: Flight**

Overnight flight from Los Angeles to Tel-Aviv.

**Day 2 – Sunday – February 6: Arrival - Jaffa - Tel Aviv**

Upon arrival at Ben Gurion airport you will be met and assisted by a Coral Travel & Tours representative at the airport. Meet your guide and drive to the coast and visit **Jaffa**. Jaffa has been known in the bible as Joppa and is considered the world's oldest port and the place where the prophet Jonah set sail for Tarshish. Jaffa is associated with the deeds of Peter. After a short drive through Tel Aviv, check into your hotel. Dinner and overnight: Hotel in Tel Aviv.

**Day 3 – Monday – February 7: Caesarea Maritime - Mt. Carmel - Megiddo - Sea of Galilee**

After our Israeli breakfast we travel via the Sharon plain to **Caesarea Maritime**. Caesarea is the place Peter led the first Gentiles to salvation (Acts 10:24), as well as the location of many New Testament stories. Explore the Roman theater and the aqueduct and view the ruins of Roman, Byzantine and Crusader times. Continue to **Mt. Carmel**, to the "**Mukhraka**", the site where Elijah challenged and defeated the 450 prophets of Baal (1 Kings 18). Drive to **Megiddo**, the fortress city of King Solomon, later built upon by King Ahab. The books of Daniel and Revelation will come alive as we study about the the Battle of Armageddon (Revelation 16:14-19). Continue on to **Nazareth**, the hometown of Jesus, and through the city of **Cana** of Galilee, where Jesus performed his first miracle (John 2: 1-11). Drive to Tiberias which is located right on the Sea of Galilee. Dinner and overnight: Hotel in Tiberias.

**Day 4 – Tuesday – February 8: Tel Dan - Caesarea Philippi - Golan Heights - Sea of Galilee**

After breakfast drive to **Tel Dan**, an important biblical city and a breathtaking nature reserve. Continue to the **Banias**, site of ancient **Caesarea Philippi**. It is here that Peter made his confession of faith in Jesus (Matthew 16:13). Drive up **Mount Hermon**, where Jesus transfigured (Matthew 17:1-8). Continue on to **Nimrod's Castle**, a medieval fortress perched high on the mountain. Enjoy a panoramic view of the Golan Heights from **Mt. Bental**, where you'll learn about the recent wars of Israel. End the day with a **boat ride on the Sea of Galilee**. Dinner and overnight: Hotel in Tiberias.

**Day 5 – Wednesday – February 9: A Day with Jesus around the Sea of Galilee**

The day starts with a drive to the **Mount of Beatitudes**, where Jesus delivered the Sermon on the Mount (Matthew 5:1-12). Then, visit **Capernaum**, the town Jesus made his home after leaving Nazareth. Capernaum is the place where Jesus recruited the first of His disciples (Matthew 4:13, Luke 4:31-37, Matthew 8:14-17, Mark 2:1-12, Matthew 8:5-13, Mark 5:21-43, Matthew 11:23-24). Visit the excavation of the ancient synagogue and the house of Peter. Continue to the newly dug site of **Bethsaida**, which is the site of the feeding of the 5000. Continue on to **Kursi**, where Jesus cast out demons from a man and allowed them to enter a herd of pigs. We'll end the day at the **Jordan River** with an opportunity to be baptized (optional). Dinner and overnight: Hotel in Tiberias.

**Day 6 – Thursday – February 10: Ein Harod - Bet She'an - Kasser El Yehud - Dead Sea**

This morning we leave the Sea of Galilee and drive to **Ein Harod**, otherwise known as Gideon's spring and the story of Gideon (Judges 7: 1-25). Continue to **Bet She'an** where recent excavations have disclosed the impressive ruins of the country's largest city in the Roman and Byzantine periods which was destroyed by an earthquake in 749 AD. Continue through the Jordan Valley past Jericho, the world's oldest walled city. This was the first city taken by Joshua when the Hebrews invaded Canaan. It was also the site of the **Mount of Temptation** (Mark 1:13). Stop at **Kasser El Yehud**, the baptismal site where Jesus was baptized by John. Drive along the shores of the Dead Sea to our hotel. In the afternoon enjoy a "float" at the **Dead Sea**. Dinner and overnight: Hotel at the Dead Sea.

**Day 7 – Friday – February 11: Massada - Ein Gedi - Qumran - Jerusalem**

Drive to **Masada**, the site of the most dramatic act in Jewish History. Explore the ancient excavation of Herod's Palaces, the bath-house, the storerooms, the Ramp, and the oldest Synagogue in the world. Continue to **Ein Gedi**, an Oasis on the Dead Sea shore. Near the 200-meter-high waterfall is a cave where David had his famous meeting with King Saul (First Samuel 24: 1-23). A walk around the reservation confirms that Ein Gedi is one of the most beautiful reservations in the world. Visit **Qumran**, where the 2000-year-old Dead Sea Scrolls were found. Then we'll drive up to Jerusalem in the traditional way and view the city from **Mt. Scopus**. Dinner and overnight: Hotel in Jerusalem.

**Day 8 – Saturday – February 12: Mt. of Olives - Gethsemane - Valley of Elah - Bet Shemesh**

After breakfast we'll ascend the **Mount of Olives** (Matthew 24:3, Luke 21:37) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the **Palm Sunday Way** to the **Garden of Gethsemane** (Matthew 26:36-46, Luke 22:39-45, Mark 14:32-42) where Jesus prayed right before he was arrested. Then we'll drive outside of Jerusalem down to the **Valley of Elah**, where David fought Goliath. Visit **Bet Shemesh**, an important biblical city. Dinner and overnight: Hotel in Jerusalem.

**Day 9 – Sunday – February 13: Temple Mount**

After breakfast drive to **Mt Moriah** (Luke 2:46-48, John, 8:1-11, Mark 13:1-2, Matthew 27:51). Visit the **Temple Mount** and view the Dome of the Rock and the El Aqsa Mosque. Visit **St. Anne's Church**, which is a fine example of Crusader architecture, and the **Pools of Bethesda**. Walk to the front of the **Eastern Gate**. Continue to the **Western Wall**, one of last remnants of the second Jewish Temple. Visit the **Davidson Center** (Southern wall excavation), the **Temple Institute**. After dinner at the hotel visit the **Rabbinical Tunnel**. Overnight: Hotel in Jerusalem.

**Day 10 – Monday – February 14: City of David - Pool of Siloam - Israel Museum - Shopping**

After breakfast visit **Mt. Ophel** and the original the **City of David**, where you'll see ruins of King David's ancient palace. See the **Gihon Spring**, and walk through the Canaanite Tunnel down to the **Pool of Sialom**. Continue to the **Israel Museum**, the **Shrine of the Book** (where some of the Dead Sea Scrolls and **Bar Kokhva** letters are exhibited) and the **Holy Land Model**. You'll have the rest of the day to have free time for shopping in a great area of Jerusalem. Dinner and Overnight: Hotel in Jerusalem.

**Day 11 – Tuesday – February 15: Yad Vashem – House of Caiaphas – Garden Tomb**

After breakfast visit **Yad Vashem**, the Holocaust Museum. Drive to Mount Zion and visit the **House of the High Priest Caiphas**. This is the place where Peter denied the Lord 3 times. End the day at the **Golgotha** and the **Garden Tomb**, where significant archaeological evidence points to this as being the site where Jesus was crucified, buried and rose again. Then we'll have our **Farewell dinner**. Late check out from hotel. Transfer to the airport for your flight home.

**Day 12 – Wednesday – February 16: Jerusalem – Tel Aviv – Los Angeles**

Overnight flight back to Los Angeles. Arrive the same day.
